One Child or Two? Sorting Out the Cochran Children



Bennie Cochran and Amanda Cochran both appear to be the children of James Abraham Lincoln Cochran and his wife, Lucinda Daugherty, who lived in a remote section of Morgan and Scott Counties in eastern Tennessee from 1880 to the early 1900s.

But were Bennie and Amanda two different people or might they be the same person? Bennie's connection to Lincoln and Lucinda rests on a single census record, while several records as well as indirect information support Amanda's identification as their daughter.

Where's Bennie?

In the 1900 U.S. census, Lincoln Cochran and his wife Lucinda were enumerated in northwestern Scott County near the Morgan County line with ten children in their household; the family lived next door to Lucinda's elderly father, John Daugherty.¹

The fourth child in Lincoln and Lucinda's household was a son, 10-year-old Bennie, born in November 1889. According to the census, Lucinda had borne ten children and all ten were still alive. The census record for the family has no other information about Bennie, including whether he had been in school that year.

After 1900, however, Bennie is missing in action. In the 1910 census enumeration, five of Lincoln and Lucinda's children were still living in their parents' Morgan County home, about 10 miles to the west of their previous residence. (See Map 1.) Lucinda was again reported as having borne ten children, but this time, only nine were still alive. In a 1972 interview, Lincoln and Lucinda's son Frank said that his brother John had died about the age of 12 after collapsing in the yard outside their home; this places John's death around 1904. Three other adult children of Lincoln and Lucinda have been located in the 1910 census, either in Tennessee or in Washington state, but Bennie cannot be found.

If Bennie was still alive in 1910, where was he? An extensive search of sources in Morgan County, as well as surrounding counties, found no records that mention him. He does not appear in land or marriage records, whether as a witness or a neighbor. He is not named as a parent in any delayed birth certificates, death certificates, or Social Security applications. Other types of local records that could be helpful are lacking: the family attended the tiny Brewstertown Church, which kept no records; no school records for this time period survived; and no newspapers were published in any of the tiny villages in Morgan County. Broadening the search to other states, including Washington, where two Cochran daughters moved as adults, found no candidate who could conceivably fit the description of Bennie from the 1900 census. He simply vanished.

Amanda Appears in Records-A Little

While Bennie Cochran was listed in the 1900 census, Amanda cannot be located in any household in Scott or Morgan County in the 1900 enumeration, including through a line-by-line search of both Lincoln and Lucinda's 1900 and 1910 neighborhoods. A broader search across the entire state also found not a single Amanda Cochran anywhere.

Amanda's first appearance in local records was in 1906, when she wed Charles Albert Brewster on 9 December in Scott County. The marriage registry form did not ask for the names of the groom and bride's parents.

The couple was enumerated four years later in Morgan County with their two-year-old daughter, Gertrude, living near Charles's father James, his aunt Farsina Brewster Berry, and his grandfather John Brewster. (Lincoln and Lucinda Cochran's 1910 residence was in a different civil district in Morgan County but was only about three miles away.) Amanda and Charles had two more children after 1910: Carrie Cordella (born in 1912) and Lawrence (born in May 1918).

Amanda Cochran Brewster died on 19 December 1918 at the age of 30 in Morgan County of pneumonia brought on by influenza.^x Her death certificate listed Linkoln Cochran and Lucinda Dougherty as her parents; the informant appears to be "H.C. Bruster," which may refer to her husband, Albert Charley.^{xi}

Evidence Supporting Amanda (and no Bennie)

Anecdotal evidence offers further clues suggesting that Amanda was Lincoln and Lucinda Cochran's child:

- Marriage ties: Two of Lincoln and Lucinda's known daughters Mina Cochran and Lorenda Cochran — married two of Charles Albert Brewster's brothers: John Samuel Brewster and Jesse Washington Brewster, respectively.xii Mina's greatgranddaughter has said that her grandmother and other family members frequently spoke of their family's three sets of "double first cousins."xiii
- <u>Scott County links</u>: Amanda married in Scott County in 1906, where Lincoln and Lucinda had lived. Another of Lincoln and Lucinda's children — Frank — also married in Scott County, and their eldest daughter Melvina Cochran Garrett continued living there after her parents had returned to Morgan County.xiv
- Naming patterns: All five of Lincoln and Lucinda's known daughters had names ending in "a" Melvina, Mina, Lenora, Lorenda, and Clarenda. Amanda's name is consistent with that pattern. In addition, Mina Cochran Brewster named one of her daughters Lola Amanda.
- <u>Potential alternative parents</u>: There are no other Cochran families in the area who could be Amanda's parents. In 1900, there were no other Cochran households in Scott County at all, and the only Cochran household in Morgan County that year was headed by Lincoln's half-brother, David, all of whose children are accounted for and none of whom was named Amanda,^{xv}
- <u>Chronological consistency</u>: Amanda and Bennie do not overlap at all in records. Bennie appears in the 1900 census and nowhere else, while Amanda is missing in 1900 and appears only in scattered records afterwards. At no time do they appear in records in the same year.

Evidence Supporting Amanda and Bennie as Separate People

The sole evidence supporting the thesis of Amanda and Bennie being two different people lies in the 1900 census. Beyond the name and sex differences, the census gives Bennie's birth month as November 1889, while Amanda's death certificate lists her birth month as July 1888. The two dates are in conflict.

However, mistakes did happen with such census transcriptions, including with this same household. For example, Lincoln's birth month in the 1900 census was listed as January, while family Bible records indicate that he was born in February. Given that the census filed with the federal government was a copy of a copy of the original, it is possible that a tired clerk miscopied the name "Amanda" (or "Mandy," as she was sometimes called) as Bennie for whatever reason.

Conclusion

Amanda Cochran was the daughter of Lincoln Cochran and Lucinda Daugherty. Born in July 1888, she likely was mistakenly identified as "Bennie" in the 1900 census. Her children, as well as the children of her sister Mina consistently and repeatedly identified themselves over the years as double first cousins, related to each other both through their Cochran mothers and their Brewster fathers.
